

Surprise Valley Chamber of Commerce Scholarship Guidelines

For

Graduating High School Students

And

Adult Continuing Education Students

Traditionally, the Surprise Valley Chamber of Commerce awards a scholarship to a graduating Surprise Valley High School student during the spring graduation ceremony.

A scholarship is also awarded in the fall to an adult, eighteen years or older, for continuing education. This applicant may be any current Surprise Valley resident or former Surprise Valley High School graduate.

The number and amount of scholarships to be awarded will be determined in February, when the Surprise Valley Chamber of Commerce approves its annual budget.

The scholarship will remain active for twelve months from the date awarded. If proof of course completion is not given within twelve months the scholarship will be forfeited.

Advertising for the graduating student scholarship will start March 1, and applications are due in the chamber office in Cedarville by May 1.

Advertising for the adult continuing education scholarship will start June 1, and applications are due in the chamber office by August 1.

Scholarships will be awarded after applications are reviewed by a scholarship committee. The committee will consist of Surprise Valley Chamber of Commerce members in good standing appointed by the chamber President. All decisions made by the committee are final.

Money is awarded as follows: one half of scholarship amount at beginning of the course/conference/or approved class and the other half after successful completion of the course/conference or approved class.

ELIGIBILITY: Current Surprise Valley High School students, residents or former Surprise Valley High School graduates are eligible to apply for a Surprise Valley Chamber of Commerce scholarship.
